Research/Creative Work Award

This honor is given by the editors of the journal recognizing the most influential article of the year. The winning article, "Stand Out in a Virtual World", was published in the September 2021 issue of Strategic Finance magazine. The Lybrand awards a Gold, Silver and Bronze Medal to the top three articles published and Certificates of Merit for other top articles. Articles submitted for publication are double-blind peer reviewed. The editorial board of the journal judge rate articles on a point scale and the top articles presented to the Lybrand Award Committee for selection of award winners.
