- Applicants must be: A PVA member, the spouse of a member, or an unmarried child (under 24 years of age) who is dependent (as defined by the IRS) on the member for principle support; A citizen of the United States; Accepted and enrolled as a full-time or part-time student in an accredited U.S. college or university.

Pat Tillman Scholarship

Available to: Active duty service members, veterans, and military spouses. Applicants must be pursuing either a full-time undergraduate degree or a full-time graduate/professional degree

Scholarship for Military Children

The Scholarships for Military Children Program was created to recognize military families' contributions to the fighting force's readiness and to celebrate the commissary's role in the military family community. Five hundred (500) scholarship grants, each for \$2,000, will be awarded for the academic school year 2025-2026.

Allied Military Scholarship

Allied Van Lines is launching a scholarship for military personnel and their dependents. Two winners will each receive a \$1,000 award. Eligibility details and entry guidelines are available.

Children of Fallen Patriot's Foundation

Providing college scholarships and educational counseling to military children who have lost a parent in combat or accidents. Our vision is that every such child can have a debt-free college education.

Patriot Legacy Fund

These scholarships are awarded annually in the amount of \$5,000 to an eligible applicant that fully embodies the spirit of service in their community as determined by the Patriot Legacy Fund scholarship committee.

Freedom Alliance Scholarship Fund

Students are eligible if they are the dependent child of an active duty Service Member who was killed or permanently disabled (100%) rating as the result of an operational mission or training accident, or who is currently certified as POW or MIA

Military Order of the Purple Heart Scholarship

Available to the recipient of a Purple Heart; a direct descendant of a member of the Military Order of the Purple Heart or of a Veteran killed in action or who died of wounds; or a spouse or widow(er) of a recipient of the Purple Heart

Scholarships for Military Children

The Scholarships for Military Children Program was created to recognize the contributions of military Families to the readiness of the fighting force and to celebrate the role of the commissary in the military Family community. If your mother or father is active duty, reserve/guard, or retired military personnel or you are the survivor of a deceased member, and you have a military dependent I.D. card you can apply!

Veterans United Foundation Scholarship

The Veterans United Foundation Scholarship creates opportunities for family members of service members and Veterans to achieve their educational dreams. Launched in 2012, the scholarship program is funded by contributions from Veterans United Home Loans and its employees. Since our scholarship program was created, over \$1 MILLION has been awarded to support the educational dreams of military families across the U.S.

National Military Family Association (NMFA) Scholarships

The scholarship program eligibility is extended to spouses of all 8 Uniformed Services which are: Army, Navy, Marine Corps, Air Force, Space Force, Coast Guard and Commissioned Corps of the USPHS and NOAA

American Military Retirees Association Scholarship

The dual purposes of this program are to provide (a) freshman year college/university/technical school scholarships to high school graduating students who (a) Are related to active, retired or deceased Exchange U. S. payroll employees and assigned military personnel, or (b) Work for the Exchange themselves and paid on the U. S. payroll. (See Personal Eligibility Criteria in paragraph 4.) This scholarship program is also consistent with the area objective of community involvement.

Army

The Women's Army Corps Veterans Association Scholarship - Established to recognize relatives of Army Service Women. This scholarship is based upon academic achievement and leadership as expressed through co-curricular activities and community involvement.

Marine Corp

Marine Corps Scholarship Foundation - Providing scholarships to military children in Undergraduate and certificate programs.

Air Force

STAP - Provided by the Air Force Aid Society that provides tuition assistance to the spouses of active-duty U.S. Air Force service members residing overseas

General Henry H. Arnold Education Grant Program - Provides \$2,000 grants to selected sons and daughters of active duty, Title 10 AGR/Reserve, Title 32 AGR performing full-time active duty, retired, retired reserve and deceased Air Force members; spouses (stateside) of active duty members and Title 10 AGR/Reservists; and surviving spouses of deceased personnel for their undergraduate studies.

Navy

Chief Petty Officer Scholarship Fund - possess a GED, be a graduating high school senior or a high school graduate intending to enter, or an undergraduate student currently enrolled in an accredited and degree granting institution of higher learning, including post-secondary Vocational Institutions. Must be a dependent child (natural or adopted), step-child, or a non-uniformed spouse (registered in DEERS) of a US Navy Active Duty, Retired, Honorably Discharged, Reserve or deceased Chief, Senior Chief, or Master Chief Petty Officer of the United States Navy

NBCC Foundation - The NBCC Foundation Military Scholarship Program is designed to encourage Service Members and Veterans to pursue careers in professional counseling. The program provides financial support to students who enroll, or seek to enroll, in a CACREP accredited counseling program during or after military service, and who commit to serving military personnel.

Wings Over America Scholarship Foundation -To provide college scholarships to dependent children and spouses of all US Navy – officer and enlisted – active duty, retired or deceased who served within Naval Air Forces. Recipients are selected on the

basis of scholastic merit and community service.

[Navy League Foundation](#) - The Navy League Foundation offers scholarships to high school seniors who will attend an accredited institution of higher education in the fall of the current award cycle. Eligible applicants must be a dependent, child, stepchild, grandchild, step-grandchild, or great-grandchild (direct descendant) of a current or former member of the U.S. Navy, Marine Corps, Coast Guard, or U.S.-flag Merchant Marine, or a current member of the Navy League of the United States.

Coast Guard

[Coast Guard Foundation](#) – Support for education is a cornerstone of our commitment to the men and women of the U.S. Coast Guard and their families.
